


Two-way conversions managed by Police:

For reasons of compliance and continuity, it is not possible to guarantee that the area discussed will not be enforced; however, your request has been recorded. Should we receive a parking complaint, we will have no option but to enforce the by-laws.

Considerations are granted <u>ONLY</u> for violations such as the three hour unposted, one hour limit parking zones and No Parking Anytime areas. In the event that a Parking Violation Notice (PVN) is received for the above—noted infraction(s), please take the tag(s) in for withdrawal to one of the two (2) Dispute/Request Review locations listed on the reverse side of the PVN along with a copy of the parking consideration and **quote the file number noted above**.

All other offences will be enforced. Please advise all those concerned that there will be **no** consideration for offences such as "No Parking within 9 metres of Intersection, No Standing, No Stopping, Stopping on Sidewalks, and Parking on Boulevards, Fire Hydrants, Fire Routes, Rush Hour Routes, and Permit Parking Streets."

Please Note: Parking consideration does not apply to vehicles under the Habitual Offenders Program or vehicles displaying expired validation stickers. All vehicles with parking consideration must be moved every 24 hours. Any vehicles displaying 3 or more Parking Infraction Notices are subject to be towed away at the owner's expense.
